  - Gender identity and rights
  - o Different value systems of students and their rights
  - What are ways to take into consideration all students in regards to:
    - Privacy
    - Safety
- Point made by Mr. Lunde and Mr. Jackson of how to protect students regarding rights to privacy.
- How does the board move forward in taking all students and their parents into consideration.
- Mention of potential case-by-case accommodation and /or outcome of "no overnight trips" allowed at KJUHSD.
- No overnights probably not the solution, due to the benefits of these experiences.
- Superintendent commended the board for not taking the "straight and narrow path" of conformity that most school districts jump into, but evaluating their own value systems and what they think is best for students and families.
